I). TUITION AGREEMENT (Continued)

Every child has a set schedule for the month. There are no allowances for absences for any reasons, whether an absence from illness or a scheduled vacation, as our teachers are scheduled and activities are coordinated with your child's attendance planned. There are no make-up days or traded days for any days missed. The Drop-In schedule is only available for children currently enrolled in our program, subject to space availability on any given day (see current "Tuition Policy" for current Drop-In rates).

Any tuition rate changes will be given to the parent/child's authorized representative at least 30-calendar days prior to new Tuition Policy effective date.

Agreements involving children whose care is funded at government-prescribed rates may specify that the effective date of a government rate change shall be considered the effective date for basic service rate modifications and that no prior notice is necessary.

II). REFUND AGREEMENT

As stated in the "General Conditions Summary", only enrollment termination during the first two (2) weeks of a probation period is there any type of refund policy.

III). TERMINATION AGREEMENT

If your child behaves in any type of harmful conduct, we will set firm, but, caring limits. We will follow our "Unsafe Behavior" guidelines as we need to ensure the safety of all our children while at school. For the safety of all concerned, continued inappropriate behavior may result in dismissal of your child in our program, which will terminate this and all agreements with Petite Sorbonne Preschool.

Per words of the Department of Social Services: The "Admissions Agreement" shall be "automatically terminated by the death of the child. No liability or debt shall accrue after the date of death."

The Department of Social Services has the right to periodically make unannounced inspections to assure the well-being of all at the facility. We welcome their visits as we should always be in compliance with their regulations. Included in their inspection is their right to discuss, face-to-face, with any child, anything regarding care in the facility. If ever your child was in contact with the Department of Social Services, you will be informed.
